News from the NYSPMR Legislative Committee

Marty Schaum, Esq. continues to closely monitor the ongoing legislative initiatives in Albany which affect our profession. Mr. Schaum reports that it has been his privilege to represent the Society for more than twenty years. The NYSPMR has joined with the NYS Coalition of Specialty Care Physicians. This is an important new development to help with our lobbying efforts in Albany and we encourage our members to become more involved in these issues. The primary focus of the Coalition is scope of practice at the NYS level. This pilot project is, in part, supported by a grant to NYSOS from the American Academy of Ophthalmology.

Lobby Day – May 11, 2010: Physicians from all localities will converge on the State Capital on May 11 to advocate for their patients and profession during the **2010 State Lobby Day**. There are currently several priority pieces of legislation being considered by the legislature, including bills that threaten to inappropriately expand the scope of practice of allied health professions into

the realm of medicine. With the balance of power in the Senate this year determined by one vote, it is critical that we have broad representation from all specialties if we are to be successful in affecting the outcome of the political process to the benefit of the patients we serve. This year's **Lobby Day** will be exciting and historical as we unite with colleagues from several other specialties with similar concerns. The day will kick off with a breakfast, legislative briefing, and Q&A session from 9:00-10:30 a.m. in Meeting Rooms 3&4 in The Egg (Empire State Plaza, Albany). Immediately following, physicians will meet with their elected representatives in the Senate and Assembly (meetings will be scheduled for you). Attendees will be paired with other physicians and/or staff and provided with easy to understand arguments, either in support of, or in opposition to particular bills of interest.
